

Dear Sir/Ma'am, The ragging scenario in Nalanda Medical College, Patna is frustratingly cruel. As freshers to the MBBS Course, we are constantly fear any interaction with Seniors and have been forced to look down at the floor throughout and bow down (at a specified ninety degree angle) to salute the seniors with "Pranam Ma'am/Boss" when we meet them. An uncomfortable uniform* has been implemented by the Seniors who force us to remove shoes of our choice and watches if they spot it. This dress code is not specified by the college-authorities. We are asked to rote memorize an introduction speech in pure Hindi which is filled with way too much of personal information and asked to recite this at the beck and call of the Seniors who meet us. We have also been asked to sing songs for the Seniors on a regular basis. Some seniors in large groups wait by the Lecture Theater route in the morning and accost us while we are going to attend classes. They also barge into our room in large groups during the Lunch Break when no Professor or Staff is present and force us to behave in a slavish manner towards them. We have been instructed to make a scam book containing personal information including e-mail ID, Phone Number and Home Address of all our batch mates and share it with the Seniors. We believe that the Seniors are forcing us to share these details and might use this to harass us later. The environment of the college is extremely disturbing both mentally and emotionally. It becomes a major problem to wait for five to ten our parents to pick us up after the college is over because of the presence of this shameful practice on the campus. The Senior Boys in large groups have been speaking and behaving inappropriately to us Fresher Girls. Senior Girls in large groups also harass us frequently. As freshers to college who are repeatedly subjected to this perverted show of power, control and humiliation which is banned, we request you to look into this matter urgently. We have received a complaint of ragging from a student of Nalanda Medical College Patna. The details are given below. You are requested to identify & counsel the victim so that they feel safe and knows that authorities are with them & action will be taken on their complaint. You are also requested not to disclose the identity of the victim.

7.1 Action to be taken by the Head of the institution by the order of Hon. Supreme Court :

on receipt of any information concerning any reported incident of ragging, the Head of institution shall immediately determine if a case under the penal laws is made out and if so, proceed to file a First Information Report (FIR), within twenty four hours of receipt of such information or recommendation, with the police and local authorities, under the appropriate penal provisions relating to one or more of the following, namely;

v. Violation of decency and morals through ragging;

vi. Injury to body, causing hurt or grievous hurt;

x. Assault as well as sexual offences or unnatural offences;

xi. Extortion;

xvii. Physical or psychological humiliation. "


